## Section B: Statement of Work

The Contractor shall replace lower bank hedges and plant beds at the main garden of Ambassador' Residence (EMR) of the U.S. Embassy in Tokyo, Japan.

### B.1 Removal Work

(1) The Contractor shall remove all shrubs, rose bushes and herbaceous perennials and annuals along bottom of bank hedges, and plant beds; and excavate all roots.

(2) The Contractor shall remove garden light fixtures along the hedges; and remove conduit feeding lightings and fixtures. (See 1.5 of the attached drawings)

(3) The Contractor shall remove stone lantern from the garden and replant in south east garden space (See 1.11 of the attached drawings); and remove the foundation.

(4) The Contractor shall remove plum tree (See 1.29 of the attached drawings) and replant in south east garden space.

### B.2 New Plant

(1) The Contractor shall add topsoil as required to bring the excavated areas up to grade, fine grade, and plant with sod and new evergreen planting strip. Suitable plants for the evergreen planting strip will include plants that can be maintained at the height of 150 to 230mm in a 600mm wide band at the toe of the slope. Preferred plant is a Dwarf Boxwood (*Buxus microphylla* var. *japonica* "Morris Midget" (KUSATSUGE). These plants or any other species selected will require regular maintenance to keep them at the prescribed dimensions. Add a metal edge on both sides, for the full length of the planted strip.

(2) For the spaces between the bottom slope of bank edge to new Kusatsuge, the Contractor shall remove 100-150mm top soil, establish new grade and plant Mondo Grass matched with existing. Plant 50 pots of 9 centimeters in diameter in 1 square meter.

(3) For the spaces between new Kusatsuge to existing lawn, the Contractor shall plant new lawn mats to be same finish height as existing lawn.

(4) The Contractor shall plant Contractor-furnished new Japanese red pine tree at south corner after plum tree. The size and form of the new pine tree shall be a mirror image of the existing west Pine, thus restoring the original design.

This does not require the Contractor to create or maintain any record that the Contractor does not maintain in the ordinary course of business or pursuant to a provision of law.

(e) (1) Notwithstanding the requirements of the clauses in paragraphs (a), (b), (c), and (d) of this clause, the Contractor is not required to flow down any FAR clause, other than those in this paragraph (e) (1) in a subcontract for commercial items. 





SCALE 1:120




2 HEDGE & BANK PLANTING AT SOUTH GARDEN, TYPICAL SECTION
