DESCRIPTION/SPECIFICATIONS

1. <u>General</u>: The Vendor shall provide all labor, tools, equipment, supervision and services, unless otherwise specified, to complete professional cleaning services of the carpets and fabricated furniture, if and when requested by the authorized personnel of the Government. All the work and procedures in the agreement shall be performed in conformity to the specifications. All local labor standards for occupational safety and health apply to this cleaning service agreement. The Vendor employees shall be on site only for contractual duties and not for other business purposes. The Vendor is allowed to park one (1) vehicle on the compound at a time.

The Vendor shall be capable of cleaning at least one (1) apartment unit per day, and up to three (3) apartment units simultaneously during the busiest season from June 1 through September 30. The Vendor shall conduct self-inspection when the cleaning work is completed in each apartment unit and report to Residential Property Unit (RPU) staff upon completion of each cleaning work with any un-removable stains or damages on the government property. If GSO/RPU staff requests to clean any carpet or furniture again, the Vendor shall come back to the site within 24 hours for re-cleaning.

The Vendor may be directed to provide professional cleaning services of furniture and carpets at the Chief of Mission Residence (CMR), and DCM's Residence (DCMR), located at 1 Nagasaka-cho, Minato-ku, Tokyo.

- **Personnel**: The Vendor shall provide a qualified workforce meeting the requirements set forth in this agreement. The Vendor shall insure that all personnel employed in the performance of this agreement are qualified and possess the necessary licenses required.
- 3. Specifications and Work Requirements:

For cleaning of area and wall-to-wall carpets:

- (a) The vendor shall use "Soil Extraction Method". The vendor shall at all times provide at least two cleaning crews with professional carpet cleaning experiences, and shall not provide any unfit person or anyone not skilled in the work assigned.
- (b) Vacuum the entire carpets prior to cleaning to remove soils effectively. Spot clean heavy residue of difficult spots such as coffee, ink, gum, and rusts.
- (c) Use a professional carpet-cleaning machine, such as "Windsor Clipper" or equivalent machines.
- (d) For cleaning solutions, use "prozyme" (consists of enzymes) or equivalent products. Use deodorizer if necessary.

- (e) After cleaning, set the pile by using a pile brush to air out the carpet and use heavy-duty fans to allow carpets to dry thoroughly.
- (f) The Vendor is responsible for moving furniture on the carpets prior to cleaning work and returning them to the original location after cleaning work is completed. Make sure not to damage furniture and interior of the buildings during the move. If any damage occurs, the Vendor will report it immediately to GSO/RPU staff.

For cleaning of upholstered furniture:

- (a) The Vendor shall apply the "Soil Extraction System", using machine and the same type of cleaning detergent as carpet cleaning. Spot clean heavy residue of difficult spots prior to the cleaning
- (b) Cleaning system used shall be provided for complete penetration of the fiber and removal of soil without over wetting and causing damage to the fabrics or any other underlying materials.

Annual Requirements:

The estimated number of carpets to be cleaned is approximately two hundred and fifty (250) per year, total 22,000 square feet. The number of furniture to be cleaned is approximately six-hundred and fifty (650) pieces per year.
