The U.S. Embassy Tokyo, Japan, invites you to enter into this BPA that establishes the terms and conditions applicable to future purchases of passenger transportation services, vehicles with drivers and/or vehicles without driver, for the U.S. Embassy Tokyo, Japan.

2. Expiration Date

This agreement shall be effective from the date of the Contracting Officer's signature and expires five years after the effective date.

3. Embassy Estimate

The U.S. Government estimates that the volume of purchases through this agreement will be \$170,000 or its equivalent in Japanese Yen.

4. Terms and Conditions

(a) The U.S. Government is not obligated to purchase any definite amount under this agreement.

(b) No single purchase will exceed USD \$10,000 or its equivalent in Japanese Yen.

(c) The total amount ordered under this agreement will not exceed \$170,000 or its equivalent in Japanese Yen.

(d) The prices to the U.S. Government shall be as low or lower than those charged your most favored customers for comparable quantities under similar terms and conditions, in addition to any discount for prompt payment.

(e) Description/Specifications

(1) Scope of Work. The BPA holder shall provide vehicles with drivers to be used by the U.S. Government as described in these specifications and in individual BPA Calls.

(2) Point of Contact. Within ten days of the award of this BPA, the BPA holder shall provide the Embassy Motorpool Supervisor with the name and contact information (minimum of telephone number and e-mail address) of a BPA holder representative who will supervise its deliveries and serve as its Point-of-Contact (POC) with the U.S. Government.

(3) Description of Services. The BPA holder agrees to provide vehicles with drivers when and as requested by the U.S. Government in BPA Calls.

(i) To the degree needed to communicate instructions related to performance under this BPA, the BPA holder's drivers shall have basic, English-language, speaking and comprehension skills.

(ii) Vehicles used for performing this BPA shall be clean and in good mechanical condition.

(iii) The BPA holder shall confirm receipt of BPA Calls within one working day of receipt.

(iv) After the service has been provided, the driver shall fill out the "Daily Vehicle Use Report" which must be signed by the passenger and submit it to the Authorized caller.

(4) The U.S. Government shall reimburse the BPA holder for unforeseen extra charges incurred by the BPA holder, e.g. parking fees, mobile-phone calls requested by the U.S. Government, and highway toll fees.

(5) The day rate for vehicles shall cover the Tokyo metropolitan area including Narita.

(6) Mileage shall not be charged for trips within the Tokyo area, including Narita and Yokosuka.

(7) Cancellation Charges. Should any order for rental of vehicles with drivers be cancelled, cancellation fees shall be paid as follows.

(i) If a BPA Call is cancelled any time prior to 00:00 hours on the calendar day on which a particular Call is scheduled to commence, the U.S. Government shall pay no cancellation fee.

(2) If a BPA Call is cancelled on the scheduled starting day but prior to the scheduled starting time, the U.S. Government shall pay cancellation charges not to exceed _____% of the scheduled rental.

or

(2) Has any unpaid Federal tax liability that has been assessed for which all judicial and administrative remedies have been exhausted or have lapsed, and that is not being paid in a timely manner pursuant to an agreement with the authority responsible for collecting the tax liability, where the awarding agency has direct knowledge of the unpaid tax liability, unless the Federal agency has considered, in accordance with its procedures, that this further action is not necessary to protect the interests of the Government.

For the purposes of section 7073, it is the Department of State's policy that no award may be made to any corporation covered by (1) or (2) above, unless the Procurement Executive has made a written determination that suspension or debarment is not necessary to protect the interests of the Government.
