

The U.S. Embassy Tokyo, Japan, invites you to enter into this BPA that establishes the terms and conditions applicable to future purchases of drapery making and installation services for the U.S. Embassy Tokyo, Japan.

2. Expiration Date

This agreement shall be effective from the date of the Contracting Officer's signature and expires five years after the effective date.

3. Embassy Estimate

The U.S. Government estimates that the volume of purchases through this agreement will be \$170,000 or its equivalent in Japanese Yen.

4. Terms and Conditions

(a) The U.S. Government is not obligated to purchase any definite amount under this agreement.

(b) No single purchase will exceed USD \$10,000 or its equivalent in Japanese Yen.

(c) The total amount ordered under this agreement will not exceed \$170,000 or its equivalent in Japanese Yen.

(d) The prices to the U.S. Government shall be as low or lower than those charged your most favored customers for comparable quantities under similar terms and conditions, in addition to any discount for prompt payment.

(e) Description/Specifications

(1) Scope of Work. The BPA holder shall provide window treatment services by making and installing draperies, sheer curtains, blinds, curtain rails, and/or films for the Mitsui Housing Compound, Off-compound Apartments, Chancery Building, and official residences (Chief of Mission Residence (CMR) and Deputy Chief of Mission Residence (DCMR)) as stated below and in individual BPA Call order.

(2) Point of Contact. Within ten days of the award of this BPA, the BPA holder shall provide the Embassy Property Supervisor with the name and contact information (minimum of telephone number and e-mail address) of a BPA holder representative who will supervise its deliveries and serve as its Point-of-Contact (POC) with the U.S. Government.

(3) Description of Services. The BPA holder agrees to provide draperY making and installation services when and as requested by the U.S. Government in BPA Call orders.

(4) Ordering. When a new requirement arises, the U.S. Government will contact the BPA holder to schedule an appointment to come to the site for measurement to obtain a quote. After obtaining the BPA holder's quote, the U.S. Government will issue a BPA Call order with the following details:

(i) Fabrics: The BPA holder furnishes fabrics for draperies and sheer curtains. The U.S. Government specifies the requirements that the BPA holder shall meet.

(ii) Pressing Finish and Tiebacks: If required, pressing finish and tiebacks shall be specified by the U.S. Government.

(iii) Lining: The use of "black-out" lining, ordinary lining or no lining shall be specified by the U.S. Government.

(5) Discrepancies. The BPA holder shall immediately report any discrepancies, concerning quantity, damage or any other factors, to the U.S. Government for clarification and/or modification of the BPA Call orders.

(6) Delivery. The BPA holder shall deliver and install draperies within the time frame specified on each BPA Call order. In case the delivery date is not specified, the BPA holder shall contact the U.S. Government to arrange the schedule. The BPA holder shall be available for urgent pickup/delivery services, such as pickup on the following day of the notice, or delivery within a few working days.

(7) Availability. The BPA holder shall provide the U.S. Government with a quote for the requirements, based upon the pricing structure in effect. The BPA holder shall immediately advise the U.S. Government if and when the requirements cannot be performed.

(8) Change of Requirements. The U.S. Government will immediately advise the BPA holder when there is any change in requirements, e.g. cancellation, extension, etc.

(1) Was convicted of a felony criminal violation under any Federal law within the preceding 24 months, where the awarding agency has direct knowledge of the conviction, unless the agency has considered, in accordance with its procedures, that this further action is not necessary to protect the interests of the Government;
or

(2) Has any unpaid Federal tax liability that has been assessed for which all judicial and administrative remedies have been exhausted or have lapsed, and that is not being paid in a timely manner pursuant to an agreement with the authority responsible for collecting the tax liability, where the awarding agency has direct knowledge of the unpaid tax liability, unless the Federal agency has considered, in accordance with its procedures, that this further action is not necessary to protect the interests of the Government.

For the purposes of section 7073, it is the Department of State's policy that no award may be made to any corporation covered by (1) or (2) above, unless the Procurement Executive has made a written determination that suspension or debarment is not necessary to protect the interests of the Government.
