The U.S. Embassy Tokyo, Japan, invites you to enter into this BPA that establishes the terms and conditions applicable to future purchases of furniture moving services for the U.S. Embassy Tokyo, Japan.

2. Expiration Date

This agreement shall be effective from the date of the Contracting Officer's signature and expires five years after the effective date.

3. Embassy Estimate

The U.S. Government estimates that the volume of purchases through this agreement will be \$150,000 or its equivalent in Japanese Yen.

4. Terms and Conditions

(a) The U.S. Government is not obligated to purchase any definite amount under this agreement.

(b) No single purchase will exceed USD \$10,000 or its equivalent in Japanese Yen.

(c) The total amount ordered under this agreement will not exceed \$150,000 or its equivalent in Japanese Yen.

(d) The prices to the U.S. Government shall be as low or lower than those charged your most favored customers for comparable quantities under similar terms and conditions, in addition to any discount for prompt payment.

(e) Description/Specifications

(1) Scope of Work. The BPA holder shall provide full property-management services for the U.S. Embassy Tokyo in Japan. The service includes packing, unpacking, storage, vaning, devanning, marking, inventorying and other related services for house-moving and office relocation as well as transporting of unloaded furniture from North Doc at Yokohama to other locations specified by the U.S. Government. The BPA holder shall perform all managerial and supervisory tasks associated with this BPA and furnish all tools, equipment, and supplies needed for performance. Such tools,

equipment, and supplies shall be supplied in sufficient quantities to ensure efficiency.

(2) Ordering

When new requirement arises, the U.S. Government shall contact the BPA holder to provide the following information to schedule the work.

- (a) Date/Time of the work (half day/full day);
- (b) Location;
- (c) Number of workers required;
- (d) Use of cart; and/or
- (e) Vehicle Requirement, if any.

The BPA holder shall include the following into the estimate.

- (a) Personnel Expenses (Worker);
- (b) Vehicle Expenses (2t/4t truck);
- (c) Estimated Highway toll and parking expenses;
- (d) Packing Materials (Carton box, Label, Tape, Carton Board, Thin Paper, Cover, Bubble Wrap, Blankets for furniture etc.);
and
- (e) Protection Materials.

After obtaining the BPA holder's estimate, the Government issues a BPA Call order.

(3) Transportation

When requested by the U.S. Government, the BPA holder shall provide 2t/4t trucks with drivers. The U.S. Government will reimburse the BPA holder for actual highway toll and parking expenses incurred to complete the service.

(4) Insurance

The BPA holder shall comply with all local laws and must specifically obtain insurance covering personal injury claims. The BPA holder shall assume full responsibility for the protection of all persons against injury by reason of its activities including matters of worker's compensation. The BPA holder shall also take reasonable efforts to protect against property loss or damage including the purchase of appropriate insurance. For the purpose stated herein, it is the sole responsibility of the BPA holder to provide sufficient insurance protection during the entire period of performance under this BPA.

(5) Change of Requirements

The U.S. Government shall immediately advise the BPA holder when there is any change in requirements, e.g. cancellation, extension, etc.

The BPA holder shall submit a summary invoice at least monthly or upon expiration of this BPA, whichever occurs first, for all services performed during a billing period. The invoice shall identify the BPA Call Order numbers covered therein, stating the total amount, and supported by recent copies of the BPA Call orders.
